COMMISSION IMPLEMENTING DECISION (EU) 2026/2015

of 4 September 2026

amending and repealing Commission Implementing Decision (EU) 2023/1586 as regards harmonised standards for machinery drafted in support of Directive 2006/42/EC of the European Parliament and of the Council

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1025/2012 of the European Parliament and of the Council of 25 October 2012 on European Standardisation, amending Council Directives 89/686/EEC and 93/15/EEC and Directives 94/9/EC, 94/25/EC, 95/16/EC, 97/23/EC, 98/34/EC, 2004/22/EC, 2007/23/EC, 2009/23/EC and 2009/105/EC of the European Parliament and of the Council and repealing Council Decision 87/95/EEC and Decision No 1673/2006/EC of the European Parliament and of the Council ⁽¹⁾, and in particular Article 10(6) thereof,

Having regard to Directive 2006/42/EC of the European Parliament and of the Council of 17 May 2006 on machinery, and amending Directive 95/16/EC ⁽²⁾, and in particular Article 7(3) thereof,

Whereas:

- (1) In accordance with Article 7 of Directive 2006/42/EC, machinery manufactured in conformity with harmonised standards, or parts thereof, the reference to which have been published in the *Official Journal of the European Union*, are to be presumed to comply with the essential health and safety requirements set out in Annex I to that Directive covered by those standards or parts thereof.
- (2) By letter M/396 of 19 December 2006, the Commission made a request to the European Committee for Standardization (CEN) and the European Committee for Electrotechnical Standardization (Cenelec) ('the first request'), for the drafting, the revision and the completion of the work on harmonised standards in support of Directive 2006/42/EC to take account of changes introduced by that Directive in comparison with Directive 98/37/EC of the European Parliament and of the Council ⁽³⁾.
- (3) Moreover, by letter M/471 of 29 June 2010, the Commission made a further request to CEN ('the second request'), for the drafting, the revision and the completion of the work on harmonised standards in support of Directive 2006/42/EC to take account of amendments and additions introduced by Directive 2009/127/EC of the European Parliament and of the Council ⁽⁴⁾ concerning the essential requirements on the protection of the environment with which, specifically, machinery for pesticide application must also comply with.

- (11) Annex I to Implementing Decision (EU) 2023/1586 lists the references of harmonised standards conferring a presumption of conformity with Directive 2006/42/EC. In order to ensure that the references of harmonised standards drafted in support of Directive 2006/42/EC are listed in one act, the references of the harmonised standards, together with the amendments and corrections thereto, referred to in the previous recital, should be included in that Annex.
- (12) Moreover, CEN corrected harmonised standards EN 13155:2020+A1:2025 and EN 14439:2025. It is therefore necessary to reflect those corrections in Part Three of Annex I to Implementing Decision (EU) 2023/1586, accordingly.
- (13) Implementing Decision (EU) 2023/1586 should therefore be amended accordingly.

- (14) Given that Directive 2006/42/EC is repealed by Regulation (EU) 2023/1230 of the European Parliament and of the Council ⁽⁶⁾ with effect from 20 January 2027, it is necessary to repeal, with effect from that date, Implementing Decision (EU) 2023/1586.
- (15) Compliance with a harmonised standard confers a presumption of conformity with the corresponding essential requirements set out in Union harmonisation legislation from the date of publication of the reference of such standard in the *Official Journal of the European Union*. This Decision should therefore enter into force on the date of its publication,

HAS ADOPTED THIS DECISION:

Article 1

Annex I to Implementing Decision (EU) 2023/1586 is amended in accordance with the Annex to this Decision.

Article 2

Implementing Decision (EU) 2023/1586 is repealed with effect from 20 January 2027.

Article 3

This Decision shall enter into force on the day of its publication in the *Official Journal of the European Union*.
